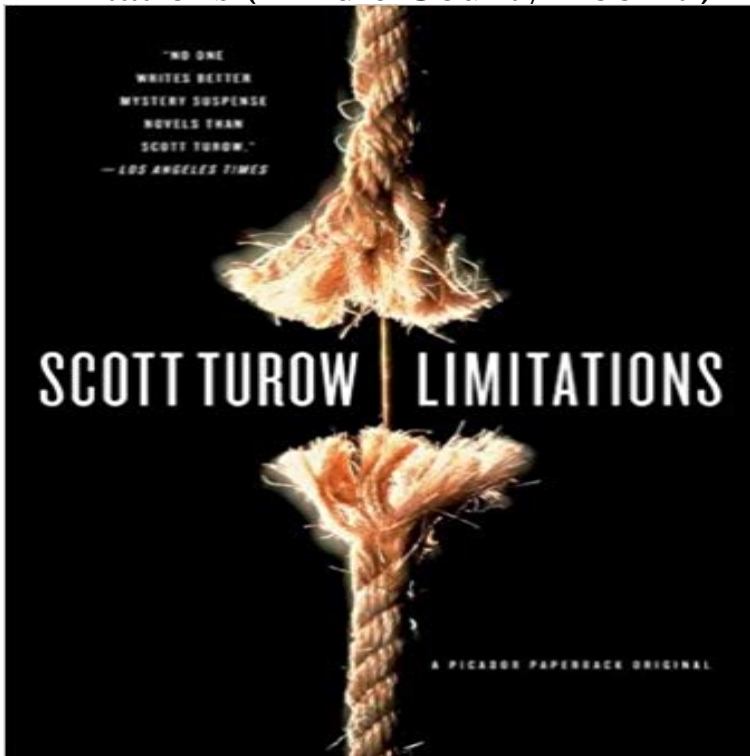


## Limitations (Kindle County Book 7)
