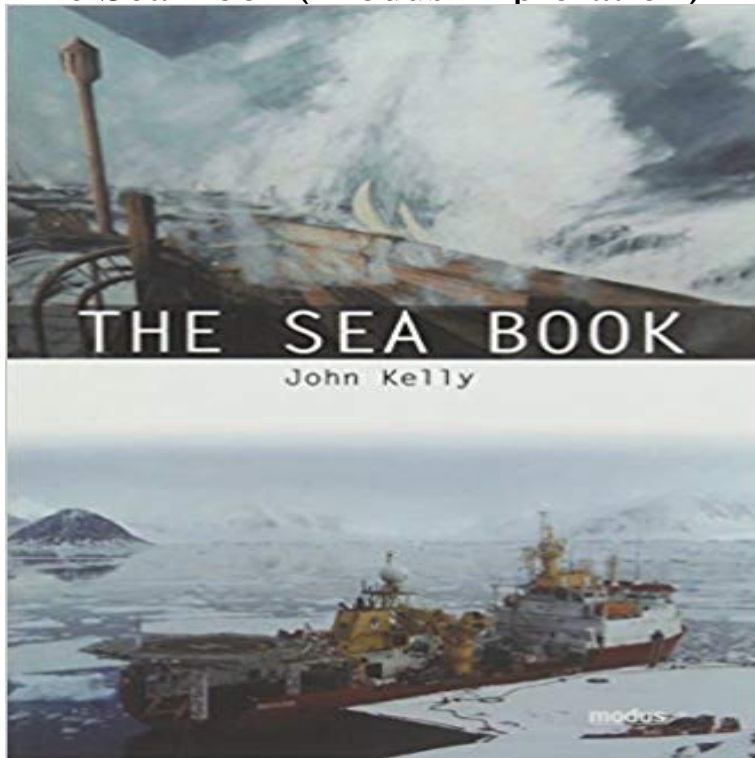


## The Sea Book (Modus Exploration)
